New requirements for monitors and TVs

Starting from January 1, 2025, the Swedish Environmental Protection Agency requires monitors to be reported separately from TVs. For screens larger than 19 inches, there are consequently distinct categories for monitors and televisions within each size group.

EPA supervision fee 2025

In addition to the aforementioned fees (POM, annual fee, and/or AR fee), a supervision fee is charged to all producers registered with the Swedish Environmental Protection Agency. The supervision fee is charged directly by the Swedish Environmental Protection Agency per producer and producer responsibility group each calendar year.
